



## **Drool at the Pool**

### **Event Rules:**

1. All owners must present proof of their dog's current Rabies vaccination.
2. All dogs must be current on all other vaccinations: **Parvovirus (CPV), Canine distemper virus (CDV), Canine adenovirus (CVA)**.
3. No dogs under 6 months of age will be permitted in the pool.
4. No human swimming is permitted- wading only.
5. No one under the age of 16 may wade in the pool.
6. Participants who are pregnant or have compromised immune systems may not enter the pool.
7. No dogs or humans with open wounds may enter the pool.
8. Activity is confined to the shallow end of the pool.
9. Splash pad is **NOT** available during the event.
10. Owners are responsible for any and all accidents and injury to their own dog.
11. Vicious or aggressive dogs may be required to leave.
12. Each dog **must** remain leashed at all times.
13. Dogs must be clean and brushed before entering the pool.
14. Owners must pick up their dog's waste.
15. Humans & canines are strongly encouraged to bathe immediately following the event.

## Assumption of Risk and Release of Liability Agreement

I hereby acknowledge that I have voluntarily elected to participate in “Drool at the Pool” offered at Oglebay, including but not limited to, allowing my pet to swim in an aquatic facility owned and operated by the Wheeling Park Commission. In consideration of the services provided by Oglebay, I hereby agree to release and discharge the Wheeling Park Commission as follows:

1. **Acknowledgment and Assumption of Risk:** I recognize the fact that there is an inherent danger in the activities, including but not limited to, injury or death, and I understand that no amount of care, caution, instruction or expertise can eliminate this inherent danger. I expressly agree and promise to accept and assume all of the existing risks related to this activity, including any risk of injury. Participation in this activity is purely voluntary.

2. **Release Provision:** As lawful consideration for being permitted by Oglebay to participate in the activity, related activities, and use their equipment, I hereby agree that I, my children, my parents, my heirs, assigns, personal representatives, guardians and estate will not make a claim against, sue, attach the property of, or prosecute the Wheeling Park Commission or its employees and volunteers for injury or damage resulting from negligence or other acts, howsoever caused, as a result of my participation in the activities.

3. **Photography:** Also, the signed and participant(s) authorize the Wheeling Park Commission to use at its discretion any photography(s) and/or video taken of the animals, children and/or adults while participating in the special event and waive any and all claims that the participant or the signed or their heirs, executors, administrators, or assigns may have or claim to have resulting from such photography(s) or reproductions thereof.

BY SIGNING THIS DOCUMENT, I ACKNOWLEDGE THAT IF ANY PERSON OR ANIMAL IS HURT OR PROPERTY IS DAMAGED DURING MY PARTICIPATION IN THIS EVENT, I MAY BE FOUND BY A COURT OF LAW TO HAVE WAIVED MY RIGHT TO MAINTAIN A LAWSUIT AGAINST THE WHEELING PARK COMMISSION ON THE BASIS OF ANY CLAIM FROM WHICH I HAVE RELEASED THEM HEREIN. I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT BETWEEN ME AND THE WHEELING PARK COMMISSION AND I SIGN IT OF MY OWN FREE WILL.
